In furtherance to our letter: DIL/SE/24-25/01, dated April 06, 2024, and pursuant to Regulation 30 read with Sub-para (20) of Para (A) of Part (A) of Schedule III of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 ('**SEBI LODR Regulations**'), we wish to inform that Gujarat Pollution Control Board ('**GPCB**'), through the Revocation of Closure Direction Notice dated April 20, 2024 ('**Revocation Order**'), has revoked the Closure Order issued on April 05, 2024. The revocation order has been issued post the inspection of the authorised officer of GPCB and allows the Company to continue operations at its industrial plant located at Plot No. 78/1, 79, 80/1, 80/2 & 81/P/A, G.I.D.C., Umbergaon - 396171, Gujarat, India. Further, the Company has paid an Interim Environmental Compensation of ₹ 2,85,000/- (Rupees Two Lakhs Eighty Five Thousand only) to GPCB, post which the said revocation order has been issued.

The said revocation order is valid for a period of three months from the date of its issue and has laid certain conditions which the Company needs to fulfil. The Company has reviewed the conditions laid down in the said revocation order and shall soon undertake the necessary action to fulfil them.

We would like to reiterate and assure our stakeholders that all our manufacturing facilities are operated consistently in compliance with applicable laws and we will continue to follow the standards as per the prescribed norms.
